Former druggist here dies at 80

V. Dale Andrews, 80 of 20 Breble St., Battle Creek died about 8 a. m. Tuesday in a Battle Creek hospital where he had been a patient since Thursday.

Mr. Andrews was a druggist, first in Bellevue and later in Battle Creek until his retirement in 1945.

He was born Oct. 19, 1884, in Nashville, son of John and Ellen (Butterfield) Andrews. He was graduated from Ferris Institute as a pharmacist and worked as a druggist in Carson City. He met his wife, the former Lois Loomis, in Carson City, and they were married in Charlotte in June 13, 1910.

In 1917 they came to Bellevue where he owned the drugstore until 1939 when they moved to Battle Creek. There he bought the Enwood Pharmacy on Main Street, and operated it until retiring in 1945. Subsequently he did relief work as a druggist in various stores in the Battle Creek area. His wife died in 1962.

Mr. Andrews was a past master of Bellevue Lodge, F&AM, and was a life member of the lodge. He is survived by three daughters, Mrs. Keith (Virginia) Masters of 250 Feld Ave., Battle Creek, Mrs. William (Barbara) Dean of Grosse Pointe Farms, and Mrs. Douglas (Marjorie) Richie of Flagler, Colo.; five grandchildren and eight step-grandchildren; and three great-grandchildren two sisters, Mrs. Mary Holman and Mrs. Belle Powers and a brother, Harley Andrews, all of Nashville.
