

Myron Rogers Dies Of Heart Attack

Myron P. Rogers, 73, of Chester township, a former member of the Eaton County board of supervisors and Chester Township clerk and treasurer from 1930 until 1940, died of a heart attack at 2 p.m. Friday while shoveling snow at his home.

He was born in Chester township, a son of Samuel and Mary (Huffman) Rogers, and had been a lifelong resident.

He owned and operated the Gresham General Store from 1923 until 1937, and then became a stone mason and carpenter.

He was a member of the Gresham Methodist church and Charlotte lodge, F&AM.

He is survived by his wife, the former Lois Garber, to whom he was married on June 18, 1913, in Bay City; two sons, Durwood and Forest of Route 5, Charlotte; three daughters, Mrs. Blake (Doris) Makley of Vermontville; Mrs. Fred (Ethel) Dickinson of Charlotte and Mrs. Robert (Beverly) Dies of Portland; a brother, Floyd of Chester township; two sisters, Mrs. Albert (Bethel) Boyles of Route 5, Charlotte, and Mrs. Beatrice King of Charlotte; 20 grandchildren and 11 great-grandchildren.

Funeral services were held at 2 p.m. Monday at the Pray Funeral Home. Burial was in Maple Hill cemetery.

Ex-Eaton Official Succumbs

CHARLOTTE—Myron P. Rogers, 73, Chester Township, died of a heart attack Friday while shoveling snow at his home. Mr. Rogers collapsed at about 2 p.m., and was dead on arrival at a Charlotte hospital.
