Envelopes for statement of returns.

(c) The various boards of county election commissioners shall furnish self-addressed
substantial paper envelopes with gummed flaps to be used by the various boards of precinct
election inspectors for sealing the statements of returns, the tally books or combined tally
and return sheets, poll lists and a certificate of election inspectors;

Containers for wrapping ballots cast.

(d) The several boards of county election commissioners shall furnish a sufficient
number of substantial paper wrappers for use in wrapping the packages or rolls of each
