GRAND RAPIDS—Mrs. Caroline Jennings McCune, widow of the former pastor of Peoples Church in East Lansing, died Sunday at the age of 87.

Mrs. McCune moved to East Lansing with her husband from Benton Harbor when he became pastor of Peoples Church in 1917. He was minister 32 years and minister emeritus until his death in 1965.

They moved to Grand Rapids

in 1964 and both entered Clark Home, a Methodist retirement home, where she died. Her life was notable for its service and activity.

In 1899, when women in higher education were pioneers, she entered Olivet College as a freshman. She prepared for an education career there and at Western Michigan University and Michigan State University. Before she earned her degree in 1929, she married Newell Avery McCune in 1907 and had one son, John, an attorney and former member of the Michigan Legislature.

Mrs. McCune was a past president of the East Lansing Women's Club, served 30 years on the YWCA Advisory Board, and was active in the American Association of University Women.

The AAUW, Lansing-East Lansing branch, named their 1953 International Study Grant in her honor, the Caroline McCune Fellowship Grant.

The McCune's home at 238 Durand, East Lansing, was an informal international center for foreign students during his ministry at Peoples Church.

Survivors include the son, John, of Reno, Nev., and two grandchildren. Services will be 9:30 a.m. Wednesday in the Clark Home Chapel, 1516 Sherman S.E., with burial in Petoskey where Mrs. McCune was born.

Services will be Wednesday at 9:30 a.m. at the M. J. Clark Memorial Home Chapel, Grand Rapids, with burial at 3:30 p.m. Wednesday at Greenwood Cemetery, Petoskey.

A memorial service will be 1:30 p.m. Friday in McCune Chapel of Peoples Church in East Lansing. Contributions may be made to the Memorial Fund of Peoples Church.
