

FRANK W. WALSH

Frank W. Walsh, former resident of Vermontville, Michigan, passed away on April 28, 1968 at his home in Clearwater, Florida.

Mr Walsh was born in Michigan on January 20, 1888. He received his B.A. degree from Western State and his M.A. degree from the University of Iowa. He was a teacher at the Bismark School until 1920 when he left the area to become a staff member of the Industrial Arts Department at the Oshkosh Normal School in Oshkosh, Wisconsin. He retired from teaching in 1931 to enter private enterprise. Mr Walsh contributed to the field of industry by designing and developing special charts used to expedite perspective drawing in industry fields. He was a life member of the American Society for Engineering Education.

His survivors include his widow, Mrs Garnet R. Walsh of Clearwater, Fla.; a daughter, Mrs Evelyn Walsh Jagdfeld of Clearwater, Fla.; a son, Richard C. Walsh, of Indianapolis, Ind.; 14 grandchildren, and 6 great-grandchildren.

Funeral services, conducted by Reverend Curtis R. Bonner of the First Methodist Church of Clearwater, were held April 23, 1968. Interment was at Sylvan Abbey Memorial Gardens in Clearwater, Florida.
