

# Ex-Banker *R. M. Bremer* Passes Here

## R. M. Bremer, 78, Also Had Realty Firm

Rudolph M. Bremer, 78, of 1000 Worden st., SE, banker and realtor here until his retirement in 1948, died Wednesday in St. Mary's hospital after a long illness.

Mr. Bremer was born in Walker township and graduated from Central High school. In his last year in high school he was employed by Grand Rapids National bank, rising to assistant cashier in 1913. In 1920 he became cashier of the former City Trust & Savings bank, and after its consolidation with Grand Rapids National Mr. Bremer was assistant cashier of the consolidated bank.

He resigned to become vice president of the Morris Plan Industrial bank in 1923. This later became Union Bank of Michigan.

In 1933 Mr. Bremer organized the Grand Rapids Mortgage corporation, acting as loan agent for Metropolitan Life Insurance Co. Two years later he organized the Bremer Realty, continuing in that business until his retirement.

Mr. Bremer was president of the Grand Rapids Credit Men's association in 1920 and president of the Grand Rapids Real Estate board in 1943-44. He was a member, former treasurer and former president of the board of trustees of Trinity Methodist church. He also was a member of York lodge No. 410, F&AM, and a member and past director of the Lions club.

Surviving are a son, Robert H. of Grand Rapids; a granddaughter and a great-grandson.

Funeral services will be held at 1:30 p. m. Saturday in the Metcalf chapel with Rev. Paul Albery officiating. Burial will be in Greenwood cemetery.
